## Contract Agreement

In consideration of the mutual covenants and agreements contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows

## Definitions .1

1.1 "4 Ball Format" refers to the format play in the Presidents Cup where two players compete on one team, playing their own ball, with the better score used for the team score.

1.2 "Presidents Cup" refers to the international men's golf competition featuring teams from the United States and from all over the world.

## Rules Regulations .2

2.1 All matches played in the 4 Ball Format in the Presidents Cup shall adhere to the rules and regulations set forth by the International Golf Federation and the Professional Golfers Association.

2.2 Each team competing in the 4 Ball Format must designate one player as the marker for the opposing team, responsible for recording the scores and ensuring the accuracy of the scorecard.

2.3 Any disputes or disagreements arising during a match in the 4 Ball Format shall be resolved in accordance with the rules and procedures established by the International Golf Federation.

2.4 The captains of the competing teams shall be responsible for ensuring that all players adhere to the rules and regulations of the 4 Ball Format and the Presidents Cup as a whole.

## Governing Law .3

This contract dispute claim arising in connection with the subject matter hereof (including non-contractual disputes claims) shall be governed by the law of the state of the Presidents Cup held.
