California Attorney Flat Fee Agreement

This Attorney Flat Fee Agreement (“Agreement”) is entered into as of [Date], by and between [Attorney Name], hereinafter referred to as “Attorney,” and [Client Name], hereinafter referred to as “Client

Services .1

Attorney agrees to provide legal services to Client related to [Description of Services] for a flat fee of [Amount] to be paid by Client as outlined in Section 2

Payment Terms .2

Client agrees to pay the flat fee of [Amount] in full upon signing this Agreement. The flat fee is non-refundable and covers all services provided by Attorney as described in Section 1

Scope Services .3

Attorney will perform the legal services outlined in Section 1 with the standard of care and skill expected of a competent attorney in [California]. Attorney will keep Client reasonably informed about the status of the matter and promptly respond to Client`s inquiries

Governing Law .4

This Agreement shall be governed by and construed in accordance with the laws of the State of California

Termination .5

Either party may terminate this Agreement at any time upon written notice to the other party. Client will remain responsible for the flat fee as outlined in Section 2 regardless of termination

This Agreement constitutes the entire understanding between the parties with respect to the subject matter hereof and supersedes all prior agreements, .whether written or oral, relating to such subject matter
