Sale Goods .1

Purchase Price .2

The Seller agrees to deliver the goods to the Buyer at the delivery location set forth in Exhibit A. The Buyer agrees to accept delivery of the goods at the delivery location

Governing Law .4

This Agreement shall be governed by and construed in accordance with the laws of the State of [State], without giving effect to any choice of law or conflict of law provisions

Entire Agreement .5

This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior and contemporaneous agreements and understandings, whether written or oral, relating to such subject matter

Counterparts .6

This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument
