Harvard University, hereinafter referred to as "University," agrees to provide legal education and services to the recipient, hereinafter referred to as "Recipient," in accordance with the terms and conditions set forth in this

The University shall provide the Recipient with access to legal courses, resources, and faculty expertise to enhance the Recipient`s knowledge and understanding of law. The University also agrees to provide guidance and support to the Recipient
.in pursuing a career in the legal field

In consideration for the services provided, the Recipient agrees to pay the University the agreed fees and expenses as per the terms of this contract. The parties acknowledge that the compensation is fair and reasonable for the services
.rendered

This contract shall be effective upon the date of signing and shall continue until terminated by mutual agreement or for breach of contract. Either party may
.terminate this contract by providing written notice to the other party
