Contract

This contract ("Contract") is entered into by and between the Idaho Senior Legal Hotline ("ISLH") and the client ("Client") for the provision of legal services to the Client.

Recitals:

WHEREAS, ISLH is a legal assistance organization dedicated to providing legal advice and representation to seniors in the state of Idaho;

WHEREAS, Client is seeking legal assistance in a matter related to senior issues;
