Indemnification and Liability .4

Each party agrees to indemnify and hold harmless the other party, and their respective agents, from and against any and all claims, damages, losses, and liabilities arising out of or in connection with the fight, regardless of the cause of .action or theory of liability asserted

Governing Law .5

This Contract shall be governed by and construed in accordance with the laws of .the jurisdiction in which the fight takes place

Entire Agreement .6

This Contract constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior and contemporaneous agreements and understandings, whether written or oral, relating to such subject matter.

Execution .7

This Contract may be executed in one or more counterparts, each of which shall be deemed original, and together shall constitute one instrument.
