Agreement

This Agreement entered into between Legal Aid of Springfield Missouri, .”hereinafter referred “the Legal Aid”, and Client, hereinafter referred “the Client

Services

The Legal Aid agrees to provide legal services to the Client in accordance with the laws and regulations of the State of Missouri. The Legal Aid shall provide legal representation in civil matters, including but not limited to, family law, .housing law, consumer law, and employment law

Client Rights Responsibilities

The Client has the right to receive competent and diligent legal representation from the Legal Aid. The Client is responsible for providing all necessary .information and documentation to the Legal Aid in a timely manner

Fees Expenses

The Legal Aid provides legal services to low-income clients on a pro bono basis. The Client is not responsible for payment of any legal fees or expenses associated .with the legal representation provided by the Legal Aid

Confidentiality

All information shared between the Client and the Legal Aid is confidential and will not be disclosed to any third party without the consent of the Client, except .as required by law

Termination

This Agreement may be terminated by either party with written notice to the other party. Upon termination, the Legal Aid will provide the Client with a .referral to another legal service provider, if necessary

Applicable Law

This Agreement shall be governed by and construed in accordance with the laws .of the State of Missouri
