The patient agrees to undergo a thorough medical and psychological 2.2 evaluation to determine their eligibility for physician assisted death in accordance with the aforementioned laws and regulations

Both parties agree to obtain the necessary legal documentation and 2.3 permissions required for physician assisted death, including but not limited to informed consent forms and second physician opinions

Section 3: Responsibilities

Both parties agree to maintain strict confidentiality and privacy regarding all 3.3 aspects of the physician assisted death process, in compliance with applicable healthcare privacy laws
