| Application Process: Applicant agrees to submit all required documentation .2 and information to DPS for review and consideration. DPS reserves the right to request additional information or conduct interviews as part of the application .process |
| Compliance with Texas Laws: Applicant agrees to comply with all Texas laws .3 and regulations governing legal residency, including but not limited to maintaining a valid Texas driver`s license, vehicle registration, and voter .registration, if eligible |
| Termination of Legal Residency: DPS reserves the right to terminate .4 Applicant`s legal residency status if it is determined that the Applicant has .violated any Texas laws or regulations pertaining to legal residency |
| Governing Law: This Contract shall be governed by and construed in .5 .accordance with the laws of the State of Texas |
