<p>Confidentiality .3</p>	<p>Client agrees to pay MSU for all legal services rendered at the standard hourly rate of \$250 per hour. Invoices shall be submitted monthly and payment is due within 30 days of .receipt</p>
<p>Termination .4</p>	<p>MSU agrees to maintain the confidentiality of all information and documents provided by the Client in connection with the legal services provided. This duty of confidentiality shall survive the termination of this .Agreement</p>
<p>Governing Law .5</p>	<p>This Agreement may be terminated by either party with 30 days` written notice. Upon termination, Client shall pay MSU for all legal services rendered up to the date of .termination</p>

accordance with the laws of the State of Michigan
