#### **Section 1. Definitions**

Cruelty" refers to any act or failure to act that causes unnecessary or "1.2" .unjustifiable physical pain, suffering, or death to an animal

#### **Section 2. Prohibited Acts**

It is prohibited to willfully and maliciously kill, maim, torture, mutilate, or 2.1 .physically abuse an animal

It is prohibited to abandon or neglect an animal, resulting in unnecessary 2.2 .suffering or death

#### **Section 3. Penalties**

Violation of Oregon animal cruelty laws may result in criminal charges, fines, 3.1 .and/or imprisonment

Civil penalties, including restitution and forfeiture of animals, may also be 3.2 .imposed
